#### **TERMS & CONDITIONS**

## **Summary Terms and Conditions:**

GB, 18+. 13<sup>th</sup> July 2024 – 19<sup>th</sup> July 2024. No purchase is necessary.

The SPAR food truck will be visiting several SPAR stores with the SPAR Truck Promotion being available to participants at those locations.

To enter the SPAR Truck Promotion, participants must scan the QR code displayed by staff at SPAR's food truck whilst the SPAR food truck is on site.
